3. HAZARDS IDENTIFICATION:

Emergency Overview

Appearance: dark-red-brown powder. **CAUTION!** May cause eye and skin irritation. May cause respiratory and digestive tract irritation. May cause methemoglobinemia.

Target Organs: Blood.

Potential Health Effects

Eyes: May cause eye irritation. This product contains an anionic dye. Similar dyes have not caused injury to the cornea or conjunctiva in documented exposure cases with human or rabbit eyes.

Skin: May cause skin irritation.

Ingestion: May cause gastrointestinal irritation with nausea, vomiting and diarrhea.

Inhalation: May cause respiratory tract irritation.

Chronic: May cause methemoglobinemia, which is characterized by chocolate-brown colored blood, headache, weakness, dizziness, breath shortness, cyanosis (bluish skin due to deficient oxygenation of blood), rapid heart rate, unconsciousness and possible death..

4. FIRST AID MEASURES:

Eyes: Immediately flush eyes with plenty of water for at least 15 minutes, occasionally lifting the upper and lower eyelids. Get medical attention immediately.
