#### **3. HAZARDS IDENTIFICATION:**

##### **Emergency Overview**

**Appearance:** Purple solid. **CAUTION!** Irritant. May cause eye and skin irritation. May cause respiratory and digestive tract irritation. The toxicological properties of this material have not been fully investigated.
